WellSky Contract/ Payment Update

Matthew DeSalvo and Artina Blackmon gave an overview of the WellSky contract and payment. Contract is currently held by Ouachita Youth & Children Family Services (OYCFS)/ Balance of State. They are the only ones to have communication with WellSky for invoices, licenses, and agreements. The due date for payment is March 31, 2024. Currently, OYCFS is unable to pay the balance \$54,000 but People Trust has offered to pay CATCH's portion of the balance or the full balance of \$54,000 to continue access with WellSky. The Emergency Solution Grant (ESG) will only reimburse OYCFS, so People Trust would have to go into contract with OYCFS for their reimbursement payment. People Trust is negotiating and drafting a contract for payment with 2 or 3 installments. People Trust would like to be a dual contract holder with OYCFS. OYCFS wanted to back out of the contract and pass it along to People Trust. People Trust will have more details by March 31.

Dr. FranSha Anderson would like to review the contract once received. Artina will make sure the contract is provided.

- o Point In Time Count- by Andre Jones
 - Provide an annual snapshot of homelessness in our area, as mandated by HUD
 - Conduct PIT Count activities in Pulaski, Saline, Prairie, and Lonoke counties
 - Ensure proper, accurate, and timely report of finding
 - Committee will meet at least monthly, beginning in July, for planning, training, and information sharing
 - Increase overall participation in PIT Count and corresponding activities
 - ❖ Increase homeless program provider/agency participation by at least 10%, to grow the reach of the PIT Count within our four-county area.
 - Explore possible adjustments to how PIT Count is conducted.
 - Increase the number of sites where PIT Count is conducted by 10%, including exploring using agencies' current programs to expand PIT Count
 - Explore the feasibility of counting in both the morning and evening, for 2025 PIT Count
 - Possibly hold an outreach event on the day of the PIT Count to increase the number of possible participants
 - Investigate an electronic PIT Count data collection service
