## **WellSky Contract/ Payment Update**

Matthew DeSalvo and Artina Blackmon gave an overview of the WellSky contract and payment.

Artina Blackmon-stated there are 5 Continuums in the State of Arkansas. Ouachita Children Youth & Family Services (OCYFS) operates on behalf of the Arkansas Balance of State Continuum of Care (CoC). People Trust is the HMIS Lead Agency for the AR-500 Continuum of Care (CoC)/CATCH. No entities could be added until the payment is made. Both entities have contributed towards the total invoice for the HMIS services in Arkansas with initial disbursements divided into two separate payments. People's Trust made a payment of \$12,560.00, while OCYFS made a payment of \$17,500.00, for a cumulative amount of \$30,060.00. ESG – through DHS stated that they would be making another payment in May.

- ❖ Dr. FranSha Anderson would like to review the contract once received. Artina will send the tentative contract that was signed will have to come from Arkansas Balance of State.
- Michelle would like to know if there are any talks about moving the contract back to AR-500 instead of Balance of State. People Trust is trying but no word currently.
- Michelle-are there any updates for reports? Artina, all reports are on schedule for this month. Some reports had to be done manually.
- Received notification from WellSky that data quality is good and would like to meet in the future. Artina will present the letter once received.
- ❖ Kurt-Does Vine & Village need to sit and hold tight about receiving access to HMIS? Artina, WellSky has released capabilities to move forward with granting access to HMIS.
